Tuition includes:

- 5 Days 4 nights at Camp Echo in Bloomingburg, NY.
- Coach Bus transportation to and from Camp Echo. Departure will be on Monday morning and return will be Friday evening. Bus will depart and return from a location nearby and chosen by Crestwood.
- All meals and snacks.
- All activities and equipment.
- Supervision by Crestwood Staff in addition to Camp Echo Directors and Staff.
- Each child is responsible for bringing all necessary clothing, footwear, bedding, towels and toiletries.
- 3 Crestwood/Camp Echo T-Shirts to be worn at Camp Echo.

My child and I understand that my child will be participating in a sleep-away camp experience and therefore my child and I agree to the following:

- To abide by all Crestwood and Camp Echo policies.
- All electronic devices are prohibited. This includes any devices that can send /receive phone calls, play video, access the internet or send/receive email.
- There will be no phone calls between my child and I until the 3rd day of my child's week away (to be arranged by Directors). One call will be permitted. The Camp Echo Directors and the Crestwood Staff will be available to speak with you.
- No food is allowed to be brought to Camp Echo. Camp Echo is a Nut Free facility.
- Parent Visiting is not allowed.
- Any medical, health, behavioral or other special needs must be discussed with a Crestwood Director at least 1 month prior to child's arrival at Camp Echo.
- Camp Echo & Crestwood are not responsible or liable for damages or losses of any personal belongings.
- If my child or I violate any Camp Echo or Crestwood Policy, my child will be removed from the program without a refund and a parent will be required to pick up the child from Camp Echo immediately.
- Tuition of \$300 is not refundable for any reason.
- I give Camp Echo permission to post photos of my child on their website.
